As members of the Board of Directors of Unit 116 we have insisted that the Unit present a positive viewpoint to the bridge community.

We have worked hard to make the right decisions for the Unit membership as a whole and worked even harder to listen to and accommodate a variety of viewpoints.

When the Board has made a decision, we worked well and collectively to implement it, even if we individually disagreed with it.

Unfortunately, a vocal group has worked to misrepresent our positions. In addition to misrepresenting what we are doing, they have:

- Not distributed and disposed of Unit literature

- Hosted games with free food and discounts to compete with Unit events, ironically these games were held by those who stated that other clubs should be forced to close regular weekly games during Unit events

- Intimidated players into not participating in Unit events

- Filed unjustified personal conduct charges against the Unit President for actions taken as a Unit official. Thankfully, these were dismissed. - Held a candidates forum before the ballot was finalized inviting only select candidates.

- Used the Buffalo Regional to promote candidates. Amazingly, our Unit was blocked from involvement in this local event.

- Purposefully withheld information requested about the District and manipulated its processes. - Created an issue about the 2005 Bylaw amendment that was passed by the membership.

We can no longer continue to be positive. We refuse to join our detractors however and go negative. Therefore, we have no choice but to resign from the Unit Board.

# Elections to the Board of Directors

Dear Members of Unit 116:

You are invited to vote for the Unit 116 Board of Directors by ballot. Balloting will be closed at 12:30 p.m. on Sunday, December 16, prior to the Unit Annual Meeting. You are to vote for THREE people for 3-year terms. Ballots with checks by more than three names will be discarded.

There are currently eight vacancies on the Board: three 3-year terms, three 2-year terms and two 1year terms. The three top vote getters will be elected for the three 3-year terms. The next three top vote getters will be elected to the three 2-year teams and the lowest vote getter will be elected for a 1-year term. There may be a 1-year appointee for the final position on the Board by the newly elected Board of Directors.

There are two proposed amendments to the Unit By-Laws. These amendments will not be voted on by ballot prior to the Annual Meeting, but instead voted on at the Annual Meeting. Please refer to the flier for the Annual Meeting for the wording of the proposed amendment changes.

1) We have a lack of communication with no *Bridge Buff* and no participation in the District newsletter.

# Please attend to vote on the following amendments to Unit 116's Bylaws:

At least four members of the Unit 116 Board of Directors has requested the following Bylaw amendment be submitted to the membership of Unit 116 at its 2007 annual meeting:

- Replace Article V, Section C, Subsection 7 Vacancies - Any vacancy on the Board of Directors may be filled by the Board of Directors and the person so appointed shall hold office during the unexpired term.
  - With Vacancies Any vacancy on the Board of Directors may be filled by the Board of Directors by an affirmative vote of not less than a majority of the Board plus one. The person so chosen shall hold office until the next election of the Unit membership where the vacancy shall be filled for the remainder of the original unexpired term by the candidate who received the largest number of votes among those candidates that were not elected for a full term. This section supersedes Article V, Section C, Subsection 5.

At least ten members of Unit 116 has petitioned the following Bylaw amendment be submitted to the membership of Unit 116 at its 2007 annual meeting:

- To be added to Article VI Unit Officers B – Election of Unit Officers – The Unit Board of Directors will elect all officers at its first meeting following the annual membership meeting and the person elected shall hold office for one year or until their successors have been duly elected. No person elected President shall serve for more than two (2) consecutive years.
- Add No Unit club owner, manager or principal shall be elected or succeed to the office of President or Vice-President.

The following recipes were obtained from Carl Stone:

# **PUMPKIN MOUSSE**

#### Mix together:

2 packages vanilla instant pudding (may use sugar free)

- 4 cups milk
- 1 can (15 oz) pumpkin (not pumpkin pie mix)
- 1 tsp. pumpkin pie spice

Fold in 8 oz. Cool Whip

Refrigerate. Can be used in a piecrust also Makes a LARGE bowl!

## PUMPKIN ROLL

6 Eggs-separated
2-8oz pkg. cream cheese--softened
1-cup flour 3 cups 10X sugar
1-cup sugar 1 tsp. vanilla
1 cup canned pumpkin 1-cup chopped walnuts
2 tsp. cinnamon
1 tsp. baking powder
1 tsp. ground ginger
1 tsp. ground nutmeg
Salt

Preheat over 375 degree; line 2 cookie sheets with foil (or wax paper) and grease and flour foil (or paper) set aside

In large bowl, beat egg whites until soft peaks form then gradually add 1/2 cup sugar until stiff peaks form (whites should stand in stiff glossy peaks)

In another bowl, mix-pumpkin, flour, cinnamon, baking powder, ginger, nutmeg, 1/2 cup sugar, 1/2 teaspoon salt, and egg yolks until well blended with wire whisk or spatula, gently fold pumpkin mixture into egg white mixture, spread half of batter in one pan, (the other half in the other pan), bake 12 min. or until top of cake springs back when touched with finger.

Meanwhile-sprinkle clean cloth towels (I use clean dish cloth) with some 10X sugar. When cake is done immediately invert onto prepared towel, carefully peel off foil (or paper). Starting at narrow end, roll cake with the towel, jelly roll fashion, place cake seam side down on wire rack and cool.

#### FILLING:

Mix at low speed, cream cheese, vanilla, 3 cups 10X sugar, 1/2 tsp. salt and walnuts. Gently unroll cakes, spread half of cream cheese mixture on each cake, almost to the edges, starting at same narrow end, re-roll each cake WITHOUT the towel, place seam side down on plate, cover and refrigerate until chilled, about and hour and then serve, I usually sprinkle a little 10X sugar on the top when getting ready to serve.

You can freeze these by wrapping each tightly in foil or freezer wrap, -to thaw let stand, wrapped, in refrigerator for about 3 hours.

# **Reporter's Column**

# The Case for Three No-Trump

This study was prompted by the principal findings of our two earlier studies, <u>Are Some Contracts</u> <u>Better Than Others</u>? And <u>Is Distribution Everything</u>? These previous studies attempted to answer two questions, namely, "What contract is made most often? and "Which contract results in the highest percentage of overtricks?" The data showed the answer to both questions was three no-trump (3NT) contract were made 78% of the time, and of those contracts made 72% scored overtricks.

Bridge players recognize that occasionally the same hand is played by some pairs at 3NT while other pairs play the hand at either a four spade (4S) or four heart (4H contract. This study examined the final scores to determine whether either contract, 4S or 4H, was favored over 3NT.

Travelers were collected from 15 bridge sessions with a total of 431 boards. Those hands, which were played in both 3NT and either 4S or 4H contracts, were sorted out, numbering 126 boards, or 29% of the total. This percentage was markedly higher than anticipated.

Using the 126 travelers, a direct comparison was made of each 3NT score with each 4S or 4H score. A total of 1,198 comparisons were made. 3NT scored higher 57% of the time, while either the 4S or 4H score was higher just 43%.

A sub sample of the 126 boards was further quantified into two groups: those holding eight trumps and those holding nine or more trumps. The results of the comparison are reported in Table 1.

#### TABLE 1

A comparison of Percentage of Contracts with Higher Scores for Hands with either 8 or 9+ trumps

	8 Trumps	9+ Trumps
3NT	59%	30%
4S or 4H	41%	70%

The finding of the 18% advantage of the 3NT contract when the combined hand contains 8 trumps would occur by chance less than one time in 100. The 40% difference where 9 or more trumps are present is equally significant. However, 9+ trump hands appeared only once in every five contracts of 4S or 4H.

Despite the favorability of the 3NT contract, current conventions and standard bidding systems preclude taking advantage of the 3NT edge in scoring. Bidding practices are geared to explore an eight-card major suit fit <u>initially</u>, and only barring this fit will no-trump be pursued. On the 126 travelers, 4S/4H contracts were bid 550 times, as opposed to only 375 bids of NT. These data would suggest reversing this bidding order, that is, seeking the no-trump contract first, and then a major fit if no-trump seemed perilous. A system of bidding, "stoppers up the line" would keep the bidding level low enough to still arrive at a 4S or 4H contract for hands lacking stoppers in all suits.

Overall, we feel that The Case For Three No-Trump stands!
